# An invitation to join the Steering Group of Community Food and Health (Scotland)



At Community Food and Health (Scotland) or CFHS, we are looking for people active in local communities to join our Steering Group. We recognise the need for greater contribution from those directly involved in delivering and supporting community based activity. Currently we have a very productive Steering Group and have representation from a range of people with experience and knowledge of nutrition, health promotion, retailing, research and policy development. National agencies such as the Scottish Executive Health Department, NHS Health Scotland, the Food Standards Agency and CoSLA are also represented, along with the UK-wide campaigning organisation Sustain, and community food initiatives.

We would like to recruit three additional community representatives to join our steering group. We would like to invite applications from volunteers, lay workers and professional fieldworkers from groups of all sizes within Scotland. If steering group members are particularly experienced, knowledgeable or interested in a particular area of work, their opinion may be sought on aspects of our work activities. Likewise steering group members may be asked to participate in small working groups as needed i.e. small grants scheme.

In order for these places to be accessible and not impact too heavily on community activity, we will compensate each community group per steering group meeting to reflect the time spent away from responsibilities plus travel expenses.

We also recognise the importance of our role in supporting community representatives and therefore we will provide assistance that will contribute towards building and developing capacity to fulfil the responsibilities of a steering group member. Together we will identify training and development opportunities and we will also provide support to help community representatives build on their current networks. Access to our library and resources will be available. Some awareness of national strategies and policy would be beneficial however we will provide support to translate local experience into policy context.
